Dear friends, family and fellow disciples of Christ,

You are a blessing to me and to our community. I can't say that enough! When I look back at 2023 I have to catch my breath. It was busy! We celebrated 175 years of ministry in our heritage sanctuary, we took a few giant steps toward vitality after several years of hibernating with Covid 19, we welcomed two retired ministers who have made a commitment to ministry here with us, we welcomed new members, new adherents, new singers, new instruments and new ideas. And once again we have a vibrant, engaging presence of young people who grace us Sunday morning with their unique perspective and sense of joy in God's love.

I would say the Holy Spirit is up to something beautiful here at Trinity-St. Andrew's United Church in Brighton. Thank you for opening your hearts and allowing her to weave and dance into your lives!

Personally, I have had a wonderful year. Finishing my spiritual direction course, we are now able to offer spiritual direction to the wider community as an outreach ministry. With our friendly visitors I hope and pray that those of you who are unable to leave your homes are feeling more connected to this community of faith than ever, through Zoom, Facebook, and in home visits. If that's not the case for you personally, would you consider reaching out to let us know?

This anniversary year inspired a new logo and t-shirt design, a booklet and "175 days of 175 years" social media campaign that included interviews, personal testimonies, history, and future direction. We hosted concerts, including a special reading of A Christmas Carol with special guests from the wider community to help launch us into Christmas weekend.

Last September we welcomed Lidia Mendez and Pastor Miguel Castro from El Salvador who visited in our community, lead worship and got to know each of us in preparation for future partnership endeavours.

We lost some dear souls who will forever live in our hearts. In celebrating their lives, we came together to worship, break bread and share memories. Truly sacred times. I also want to lift up the strong, faithful leadership of this church community. In September the rainbow steps leading into our sanctuary were painted over with black paint. A young person in our congregation noticed it first, and told her grandmother, "Someone stole my colours!" With strong leadership from our Affirm committee, and the careful networking and support they have nurtured with the community of Brighton, we were able to hold a painting party with people of all ages grabbing a brush and restoring their favourite colours.

Our outreach committee is constantly looking for ways to help us walk in right relations with the First Nations of this area, in particular Alderville and Tyendinega. I know there were plans started in 2023 that will come to fruition in 2024. This same team has helped us to understand prejudice and has helped us to enable food sharing in our community.

We have an accessible building with automated doors, increased lighting, new ovens, the process has begun to demolish an aging manse next door, and creative wondering about a green space that can honour the years of ministry conducted from that building. We had regular volunteers, in particular a big thank you to Barry and Beth Street, who kept our building in good shape while our custodian took a leave of absence. Thank you is not enough...

Did I mention that we are a busy place?

For myself, I became speaker of the assembly of elders for the East Central Ontario Regional Council, as well as being the leading commissioner to General Council 44. While this occupied much of my time, I also did my best to visit those who have difficulty getting to church, prepared and sometimes shared regular worship, and tried to support all of your ministries in any way I could.

I need to thank my fellow team, Pamela Maloney, Barry Ott and Sandra Candeloro who support each other, encourage each other, and are an absolute blessing to work with. I want to thank council, especially Lori Cooper who chairs council, for the careful stewardship of our community's resources. I would also like to lift up the blessing of Rev. Jackie Harper, who is bringing a lifetime of experience to our youth programming and to Pastor Ian Robb, who has also joined our congregation and made a commitment to supporting pastoral care amongst us. Thank you for choosing to continue your ministry in retirement with us.

Finally, may we all bow our heads in humility that all these blessings have been placed before us, and that we have been given the gifts, the energy and community to respond to the nudging of Christ's spirit who calls us to care for the poor, feed the hungry and shelter the homeless. May the next year give us even more opportunities to serve.

## Trustees Report

The current Board of Trustees comprises of Karen Martin, Helen Bonisteel and Jack Reed chair. The 2023 board of three members has accepted the requests of Barry Street and Colin Wright to be nominated as trustees.

The Manse structure demolition was approved by our church council and regional council in late 2022 and passed at the 2023 AGM. The tenants were given more than five months notice to relocate and did so in May 2023. A demolition permit was then filed with Brighton Building Department for processing and once approved the hiring of a contractor to remove the building was accomplished. The demolition goal was to leave the building site as a clean level space for church use. The permit was approved after some delay regarding unanswered declarations about building material status and how and where removal of building debris was to take place. A masonry restoration contractor was engaged to remove a portion of the old bricks for his future restoration work thus reducing bricks going to land fill. An agreement was made that his time and effort to remove without any cost, as many bricks as he might require. In return, he agreed to restore some areas of the exterior church walls for free later this summer.

Hydro and water services have been disconnected from the Manse. The gas company is still pending for meter and gas line removal and are quoting a wait time of 6 to 8 week to arrange for this. A demolition contractor has been selected and will be scheduled to start the building removal process once the gas service is disconnected from site. This phase is expected to start approximately mid to late April.

Church property insurance still remains a very large cost item for the church budget. The insurance market costs to insure older building pre current fire code construction are still trending upwards over the past several years. The Trustees are recommending that TSA renew the church insurance this June for the coming year with our current insurance broker. This will give the Trustees an opportunity to compare insurance costs with the new UCC self insurance plan and our current insurer once the Manse is no longer an insurance liability. Without the the Manse being insured this forth coming term, our insurance premiums should be reduced.

## Trinity—St. Andrew's United Church Minutes of the Annual General Meeting March 26, 2023

Reverend Wanda Stride called the meeting to order at 12:10 p.m. with a recognition that the land on which we meet is the traditional territory of the Mississauga of Alderville, and we thank them for their stewardship as we work on improving our knowledge and understanding of our colonial history.

Rev. Stride then led us in an opening prayer, asking for guidance for the meeting and for the future of the body of Christ in Brighton. She prayed for a blessing on all those members that we have lost over the past year, with thanks for all their many contributions to the life of Trinity-St. Andrew's.

Rev. Stride made the happy announcement that Kaitlyn Ostrander's ordination service is scheduled for the weekend of May 5<sup>th</sup>, and those wishing to attend in person should register with Pamela Maloney at the office.

Rev. Stride called for nominations for the chair of the meeting. Jean Green nominated Brian Ostrander, seconded by Sharon McMullen. Carried.

Janet Kivisto nominated Lori Cooper and Janet Enns to act as secretary and tech team. Seconded by Brian Ostrander. Carried.

Brian Ostrander then took the chair and asked for a motion to extend voting privileges to adherents on all matters coming before this Annual General Meeting.

Carried.

Barry Ott moved that the agenda be accepted as presented, seconded by Jack Reed.

Carried.

Moved by Ryan Reckenberg and seconded by Derek Madder that the congregation accepts the summary of the minutes from the Annual General Meeting for the reporting year 2021 held on May 1, 2022. **Carried.** 

There was no business arising from the minutes.

#### Correspondence:

Brian read the appended letter from David Smith regarding concerns with the foundation in the northeast and southwest corners.

A motion to receive the letter as information was moved by Jack Reed and seconded by Elizabeth Scriven. **Carried.** 

Discussion ensued regarding next steps, previous estimates, funds available, creation of an investigative team, etc. The chair recommended that the discussion be referred to the next council meeting for further action. Agreement by consensus.

A motion was presented by Ryan Reckenberg and seconded by Jack Reed, that the congregation accepts the reports from the:

- East Central Ontario Regional Council representatives (pages 21)

- Board of Trustees (page 8)
- Chair of Council report (page 7)

#### Carried.

Further information was received from Paul Cook regarding a requirement for a living story of our church to be posted on the United Church Hub, which he will take to Council for action.

Neva Moelker made the request that last names be included on all reports for the benefit of newcomers.

Elizabeth Scriven moved, seconded by Derek Madder that the congregation accepts the following reports, with a correction to the Stewardship report that the excess money from the Church-cation fundraiser in fact went towards alleviating the deficit:

- UCW report (page 27)
- Membership statistics report (page 16)

Carried.

There was no report or discussion around a Mission and Service goal.

Moved by Keith Smith and seconded by Barry Ott, that the congregation accept the report from the Treasurer (page 30)

And further that the congregation accepts the General Fund report as presented (page 31)

And further that the congregation accepts the Position statement as presented (page 33)

Some discussion ensued around the need to increase income, and keep discretionary spending down as much as possible. Elizabeth Scriven suggested that she could draw the attention of the specific chairs to the issue if their spending is in danger of exceeding their budget.

Carried.

Moved by Barry Street and seconded by Elizabeth Scriven that the Congregation of Trinity-St. Andrew's United Church appoints Isabelle Brose to review the 2023 financial statements, with thanks for stepping in this year. **Carried.** 

Helen Bonisteel moved and Sharon Graham seconded that the Congregation of Trinity-St. Andrew's United Church authorizes the Treasurer to enter into an agreement with 1856186 Ontario Inc. for the provision of bookkeeping services.

Carried.

Moved by Lori Cooper and seconded by Derek Madder that the congregation accepts the review of the financial statements ending December 31, 2022, as presented.

Carried.

The following amendments were made to the Nominations Report:

Sharon McMullen as chair of Fundraising has been added to the Stewardhsip List. Remove Helen Phillips from the Clothing Depot.

Add Jack Reed and Helen Bonisteel to the Clothing Depot.

Add Lori Cooper to the Chair of Council and remove from M&P Chair.

Move Neva Moelker to chair of M&P. Add Barry Street and Ryan Reckenberg to M&P. Add Colin Wright to Trustees. Add Derrek Madder to Property Management. Appeal for co-chair for Affirm Committee.

Moved by Cindy Clitherow and seconded by Jack Reed to approve the nominations as amended.

A reminder came from the chair that all committees need willing helpers as well as members, and that at any time during the year a person may step forward to assist in whatever way or timeframe they feel able to contribute.

Carried.

Moved by Paul Cook and seconded by Lee Farmes That the congregation accepts the 2023 Budget as presented.

Brian Ostrander reiterated that we do not have an expenditure problem, we have a revenue problem and therefore a number of avenues are being explored, including a membership drive, a concert series, etc.

Keith Smith commented that we should all be looking at increasing our donation by at least the cost of living increase.

A number of questions were answered by the treasurer.

Treasurer Elizabeth Scriven raised the question of when to sound the alarm about an increasing deficit. She promised to continue to keep us informed monthly, but that serious thought needs to be put into the problem and concrete actions need to be taken. Eventually this trend will drain all our reserves.

Motion to accept the budget carried.

#### New Business

There was some discussion around the potential to use the demolition of the manse as a fundraising event by selling off certain items, turns with a sledgehammer, etc. Ryan Reckenberg said he would look into it but reminded us that the contractor would be looking to use some of those items towards their own profit as it is part of their business. He may be able to have some bricks made available for the repair of the main building.

It was noted that the demolition permit for the manse has been signed by the representatives from the church and will be delivered to the municipality within the week.

Lastly, in memory of Joe McMullen, the Chair thanked all the staff profusely for their wonderful work: Rev. Stride for her inspiration, talent, leadership and pastoral care; Pamela Maloney for her organizational skills, computer expertise, patience and willingness; Barry Ott for our sparkling church, handyperson work and cheerful presence; Sandra Candeloro for her musicianship, positivity and willingness to use her many other skills for TSA.

Barry Ott moved and Ken Mcklintock seconded that the meeting be adjourned.

Carried.

Sorry that I'm unable to attend the Annual General Meeting for Trinity St Andrews. Please bring this information to the attention of the person chairing the meeting which I believe is Brian Ostrander.

I am very concerned about the failing of the sanctuary foundation especially in the northeast and southwest corners. At first glance in the northeast corner it may appear the bricks are fine from the outside but these same bricks have moved outwards about 1 inch or 2.5 cm taking the windows with them as the foundation weakens. The other corner is having the runoff from the new hall splashing onto the foundation destroying the bricks and mortar.

The old Presbyterian Church in Brighton had the same issue however they let the problem go too far. The cost of the repair was up to a \$380,000 range which the members of this Church could not afford.

However the building inspector the Presbyterian Church hired said he would not give them a written report because he would have to close the building as it was unsafe. He also told them not to allow others to inspect the building or they would do the same thing. He suggested they plan to end with the Christmas service and then have the building torn down. Similar to our problems with the Manse.

Trinity-St. Andrews could have the same thing happen and it would be cheaper to fix now and we also would be able to use the hall for fundraising to pay for the repairs. We may not have the membership to raise the additional money but others in the town may want to save a very historical building in the town. Additionally there may be grants we can get to save the building.

I would like at the minimum to see the problem brought to the members attention so we can find solutions to save the sanctuary for the future.

Neva Moelker accepted the position of chair and together this committee has worked diligently fulfilling their duties as presented.


We'd like to extend our appreciation to Lori Cooper who served faithfully on this committee for many years.

#### Outreach

#### **Black History Month: February**

Committee members contributed text inserts for 25 days out of the 175-day anniversary project that commemorated the history of TSAUC, its members and relationships within the larger community. Outreach Committee focus was on history of the treaties in this area with nearby Indigenous communities.

#### National Day of Truth and Reconciliation, September 30

The committee hosted five Zoom education sessions from the National Centre for Truth and Reconciliation in the week preceding the National Day of Truth & Reconciliation. Members of the committee accompanied Rev. Wanda to Alderville First Nation on September 30 to participate in their walk and ceremony of commemoration. In partnership with the Brighton Public Library, the committee publicized the library's invitation to attend a film presenting Indigenous artists and historians.

#### **Migrant Workers**

Through the "growing" season, there were a variety of opportunities for contact with the migrant workers in our area. Assistance was provided for transportation and/or communication for medical-related needs. Four dinners were hosted for the workers during their time here.

#### Plastic bag collection

In response to a request from a member of Frankford United Church, Outreach agreed to go forward with a plan to collect plastic milk bag wrappers for Frankford UC's project to weave sleeping/ sitting mats for the homeless. A collection box was placed at the back of TSAUC sanctuary.

#### Fund-raiser: December

TSA held its annual sale of Fair-Trade merchandise from Ten Thousand Villages/Cobourg. We had a record sale of approximately \$5600 of merchandise. TSA earns 15% of the total which enabled us to donate \$844.80 to support the ECORC irrigation project in El Salvador.

#### **United Church Special Days**

Through the year, members of the committee submitted inserts for certain weekly bulletins to commemorate **special** days, such as Asian Heritage Month, National Day of Remembrance and Action on Violence against Women and Girls, Transgender Day of Remembrance and Black History Month.

#### **Education related to Anti-Racism, Reconciliation & Social Justice**

Through the year, committee members monitored, attended and promoted various online education opportunities related to these important topics.

#### East Central Ontario Regional Council (ECORC)

I serve as a Trinity-St. Andrew's representative to ECORC along with Helmut Enns. Currently my role with the region is in Pastoral Relations where I act as liaison with other Communities of Faith to guide them in their search for new ministers. One of the largest and most challenging projects that I will be working on with the Region and Wanda in the following year will be developing a collaborative ministry plan for many of the churches in our area. Many of the churches in our local area are quite small in numbers and cannot support full time ministry. But we still want to ensure those communities of faith will survive long term. So why not try to share ministers among the various churches and thereby keep these churches viable and ministers employed. This is all part of discovering how we do church differently in the future and adapt to the opportunities that come our way.

Helmut too is very busy and serves a vital role in the life of the church. He adds the following:

"The body is a unit, though it is composed of many parts. And although its parts are many, they all form one body. So it is with Christ." 1 Corinthians 12:14. This can also describe our church, or in my case ECORC, East Central Ontario Regional Council. One of these many parts of ECORC is the IJRR, Indigenous Justice and Respectful Relations Forum, which seeks to assist us in exploring IJRR. One way we are doing this is with three lending libraries, which are circulating in ECORC. Each library consists of three display cases or "suitcases, 24 inches high and 18 inches wide. Each display case contains about a dozen books, for a total of 30 – 36 books in each library. The libraries stay in one church for about 6 weeks. Churches are invited to request a library from Jackie Harper or Helmut Enns. Isn't that convenient for us?

With a new Chair and enthusiastic members, the Affirm and Equity Committee had a busy 2023.

#### **Events Celebrated**

- National Affirm Day/PIE Day March 14, 2023 held evening event: watched UC Moderator's PIE Day message, had a discussion, sang several songs with ukulele accompaniment followed by pizza pie.
- International Day against Homophobia, Transphobia and Biphobia – May 17, 2023; Rev. Stride spoke to the importance of this day during the service on May 14.
- Pride Sunday June 4, 2023: 2<sup>nd</sup> annual Pride Walk and Worship Service in Memorial Park; 60 people attended
- Pride Pop-Up Event June 11, 2023; inaugural event hosted by the Peterborough AIDS Resource Network (PARN); TSA had a table at this event.
- Repainting of church's Rainbow Steps October 27, 2023. After being vandalized, TSA quickly pulled a group together and repainted the steps in front of our church.
- Transgender Day of Remembrance November 20, 2023
- World AIDS Day December 1, 2023
- Annual celebration of becoming an Affirming Congregation and 175<sup>th</sup> anniversary of Trinity St. Andrew's United Church November 12, 2023

#### **Key Accomplishments**

- Restarted Affirm Committee after several years of hiatus due to lack of leadership/members
- Developed work plan for the coming year
- Requested and received approval on June 15, 2023 from Trinity-St. Andrew's United Church Council to rename the committee to "Affirm and Equity Committee" to better reflect our expanded mandate that includes accessibility and scent free environment policies in addition to LGBTQIA+ and Two Spirit topics.
- From two Pride events in June, raised \$515 in freewill donations which were donated to the new Rainbow Youth Centre that is being established in Brighton. The Centre is part of the PARN's ongoing Youth Programs and will be





set up in the back of the Tin Roof Ice Creamery store on Prince Edward Street in downtown Brighton.

- Created a monthly feature on the church's bulletin board that provides information about LGBTQIA+ and Two Spirit people. Congregants are invited to speak with Affirm and Equity Committee members if they have questions or would like additional support.
- Undertook several letter writing campaigns for 2SLGBTQ+ causes, including one in support of a \$9,500 grant for the Rainbow Youth Centre from the Municipality of Brighton.
- Requested that the Women's Washroom receive an automated door opener to make it fully accessible. This work was completed in Fall 2023.
- Ensured that "scent free" signage was posted around the church and added reminders to the church's order of service each Sunday and to the monthly newsletter.
- Discussed with the Hospitality Committee the need to provide gluten free and dairy free food options during fellowship time and other events, as appropriate. Created signage for gluten free and dairy free food options to clearly identify these products.

#### **Property Management and Maintenance**

This year marked true growth, and rebirth for Trinity-St. Andrew's United Church. Fully re-opening our doors and our programs and our commitment to the community. We have never been busier and more active, allowing access to worthy causes, great programs and concerts, and welcoming new and longtime members of the congregation back to the building.

We have also had wonderful news – the welcoming back of our custodian Barry Ott to the TSAUC staff family after his long-term absence, and the miracle of his wife Catherine's ongoing recovery. We have truly missed him. I would like to thank all of those who volunteered who picked up the cleaning duties in his absence, all of your wonderful work was one of the main reasons that we were able to continue as normal throughout Barry's absence. You are heroes of the congregation as well.

As is to be expected there have been several expenses from our committee to keep the building running as smoothly as possible. Both roof-top HVAC units have had their blower motors replaced, at approximately \$4000-5000 per motor. As well—there has been/will have been lighting done both inside the sanctuary for safety/security during power outages for emergency exits as well as outside in the parking lot to help give a brighter illumination. I am happy that this will make the parking lot and the building safer to be around in the evening and will make it safer and far easier to navigate in the parking lot.

The manse despite still being present on its site, will soon be demolished and there is permitting and utility service (sewer, water, hydro and gas) shut offs underway, and a contracted demolition company that is looking forward to giving us the land back, and have provided a quote that was lower than the original contractor by \$5000! As a side benefit the back fill from the demolition and gravel and dirt used will also be used and available for the opposite side of the parking lot where we have been struggling with civil earthwork/ landslide issues washing out part of the earth from near "the Depot" building. Please try not to park nearby "The Clothing Depot", as some of the earth has been eroding under the tarmac/parking lot cement.

The Property Committee is also currently looking at different solutions to having a water softener system installed to help with hard water throughout the building, both in the kitchen and in the bathrooms to prevent expensive and unsightly scale build up.

The Property Committee is operating within its current budget and should be within its budget for the next year and will be looking for funds to work on some of the projects that need to be done in the near future.

And as always, we are looking for people to volunteer to serve on the Property Committee, it doesn't need to be in a physical manner, we are looking for people who can help plan, oversee work being done, and help in the prioritization of future projects to be worked towards.
